**Subject: Proposed Technical Changes** 

Renewable Energy Approval (No. 2871-8UKGPC)

**South Kent Wind Project** 

South Kent Wind L.P. is proposing to develop the South Kent Wind Project, a 270 MW wind energy project (hereinafter referred to as the "Project"), consisting of approximately 124 operational wind turbines, as well as supporting infrastructure, including access roads, construction and turnaround areas, and buried and/or overhead collection/transmission lines. The collection/transmission line will include approximately 34 km of 230 kV transmission line and two substations to enable step-up of the voltage from 34.5 kV to 230 kV to connect to the Chatham Switching Station. The Project area is located in the Municipality of Chatham-Kent in southwestern Ontario, south of Highway 401 between the towns of Tilbury and Ridgetown to the west and east, respectively.

The Ministry of the Environment (MOE) issued a Renewable Energy Approval (REA) for the Project (No. 2871-8UKGPC) on June 15, 2012. Since issuance of the Approval, South Kent Wind L.P. has identified a need to make revisions to the layout of the facility, as well as de-rating two wind turbines in the facility.

This letter summarizes the proposed changes to the Project, including the rationale for each change, and identifies the amendments to each of the supporting documents prepared for the REA application to incorporate the proposed Project changes. This letter also provides an assessment of the potential for new negative effects not addressed in the initial REA supporting documentation.

# 1. Proposed Project Changes

The proposed changes are as follows:

- Movement of Turbine P012 9.6 m from previous position approved within the REA for the Project.
- Movement of Turbine P038 52 m from previous position approved within the REA for the Project, and de-rating of the turbine from 105 dBA to 101 dBA.
- Movement of Turbine P099 34 m from the position approved within the REA for the Project.
- De-rating of Turbine P039 from 105 dBA to 104 dBA.

The revised locations of Turbines P012, P038 and P099 are shown in Attachment A.





Table 1.1 provides a description of each proposed change, the rationale for the change, an assessment of potential for altered environmental effects and any additional mitigation or monitoring required.

Overall, the only additional negative effects identified as a result of these changes are minor increases in noise at some sensitive receptors. All receptors remain compliant. Based on this, and through consultation with Sandra Guido of the MOE on December 3, 2012, the proposed changes are determined to be a Technical Amendment.





# 2. Summary of Revisions to REA Supporting Documents

This section identifies the amendments, where required, to each of the supporting documents submitted with the original REA Application that are required to address the proposed Project changes.

## 2.1 Project Description Report

The primary change in relation to Project Description Report (PDR) is the location of the turbines as shown in Figures 1.1 to 1.3 of the PDR. The PDR is amended through provision of figures, showing the original location of the turbines and associated infrastructure and the amended locations, in Attachment A of this letter.

# 2.2 Construction Plan Report

The primary change in relation to the Construction Plan Report (CPR) is the location of the relocated turbines as shown in the site plans in Appendix A of the CPR. The CPR is amended through provision of figures showing the original location of the turbines and associated infrastructure and the amended locations, in Attachment A of this letter.

## 2.3 Design and Operations Report

With respect to the Design and Operations Report (DOR), there are two changes.

The figures in Appendix A of the DOR are amended through provision of figures, showing the original location of the turbines and associated infrastructure and the amended locations, in Attachment A of this letter.

In addition, revisions to Table 7.1 of the DOR are made according to Table 2.1 below. Though some of the specific distances to neighbouring properties have changed, the results of the property line setback assessment with respect to potential risks as identified in Section 7.2 of the DOR require no revision.

#### 2.4 Decommissioning Plan Report

There are no revisions required to the Decommissioning Plan Report

#### 2.5 Wind Turbine Specifications Report

There are no revisions required to the Wind Turbine Specifications Report

#### 2.6 Noise Study Report

The noise study report has been revised to account for the revised turbine locations. The revised report is provided along with this letter.





# 2.7 Water Body Reports

There are no waterbodies located within 120 m of either the original or revised location of Turbines P038 and P099. A waterbody is located within 120 m of Turbine P012, however relocation of this turbine will not result in any change to the separation between the turbine and the feature. As a result, there are no revisions required to impacts or mitigation measures identified within the Water Body Environmental Impact Study. Locations of the water bodies in relation to the revised locations of the turbines are shown in Attachment A.

## 2.8 Natural Heritage Assessment Reports

There are no significant natural features located within 120 m of either the original or revised locations of any of the turbines. As a result, there are no revisions required to impacts or mitigation measures identified within the Natural Heritage Environmental Impact Study. Significant natural features, where present in the regional landscape, are shown in Attachment A. The MNR is copied on this letter to ensure that they are aware of the revised locations of these Project components.

## 2.9 Archaeological Assessment Reports

The revised Project components are all located within the existing extent of the Stage 1 and 2 archaeological investigation area (as shown in the figures in Attachment A). Therefore, no revision to these reports, or additional assessments/reporting to MTCS, are required.

#### 2.10 Heritage Assessment Report

No new properties have been added to the Project as a result of the changes identified in this letter, and none of the turbines subject to changes are identified within the recommendations of the Heritage Assessment Report. Therefore, there are no revisions required to the Heritage Assessment Report, and no further correspondence with MTCS is necessary.

#### 3. Consultation

As described previously, this amendment has been determined to be a Technical Amendment. Accordingly, as directed by MOE, we have notified via letter on April 5 and April 9, 2013, landowners within 1500 m of the affected turbine locations (both original and revised locations where relevant), Aboriginal communities, and the municipality about these proposed changes. A sample notification and the mailing list used to distribute this notice are provided in Attachment B.






# Attachment A Maps of Revised Turbine Locations
