Enterprise Solar GP Inc. Alter Enterprise 1070S Substation	Proceeding 28315 Application 28315-A002

Enterprise Solar GP Inc., pursuant to Permit and Licence 27793-D03-2022,¹ has approval to construct and operate the Enterprise 1070S Substation, located near the town of Vulcan. By Application 28315-A002, registered on July 6, 2023, Enterprise Solar applied to the Alberta Utilities Commission for amendments to the equipment of the approved, but not yet constructed substation.

The Commission, pursuant to sections 14, 15 and 19 of the *Hydro and Electric Energy Act*, approved the application in Decision 28315-D01-2023² and granted Enterprise Solar a permit to alter the design and construct, and a licence to operate the substation subject to the provisions of the *Hydro and Electric Energy Act* and the *Alberta Utilities Commission Act*, any regulations made under the acts, any orders made under the acts, the Commission rules made pursuant to the *Alberta Utilities Commission Act*, and the following terms and conditions:

1. The substation shall be wholly located in the southwest quarter of Section 26, Township 16, Range 25, west of the Fourth Meridian, as further described in the application and Application 26322-A002.
2. Specifications of the substation shall be:
 - (a) one 138/34.5-kilovolt (kV), 50/66.7/83.3-megavolt ampere (MVA) transformer
 - (b) one 138-kV circuit breaker
 - (c) four 34.5-kV circuit breakers
 - (d) it shall be enclosed within a secure fence and include other substation equipment, as further described in the application and Application 26322-A002
3. Unless otherwise authorized by the Commission, construction of the substation shall be completed by June 1, 2025.
4. Enterprise Solar shall file with the Commission, within 30 days of completing construction of the substation, the energization certificate for the substation issued by Enterprise Solar to confirm that the substation has been completed and the substation is being operated in accordance with the provisions of this permit and licence.

The Commission may cancel or suspend this permit and licence, in whole or in part, in accordance with Section 41 of the *Hydro and Electric Energy Act* or may review this permit and licence, in whole or in part, upon its own motion or upon an application by an interested party, in accordance with Section 10 of the *Alberta Utilities Commission Act*.

The Commission may, no later than 60 days from the date of this permit and licence and without notice, correct typographical, spelling and calculation errors and other similar types of errors and post the corrected permit and licence on its website.
